I. INSTRUCTIONS

- Form groups of 4-5 people.
- The length of your presentation is between 8-10 minutes.
- Use a power point / Prezi presentation to support your ideas.

II. OBJECTIVES

- Develop communication and expository skills.
- Collect and organize information to create an expository text.
- Use specific vocabulary to talk about human rights violations, consequences of them and arguments for and against a specific situation.

III.IMPORTANT POINTS TO KEEP IN MIND

- Research human rights violations that are taken place in a specific country. Pay particular attention to the people involved, the reasons given by the government/ authorities/ people committing the violations for these situations and the consequences of them.
- Present your findings to the class.
- Give your opinion on the situation and a possible solution for this.

IV. KEY QUESTIONS

- Who is violating Human Rights? Where in the world is this happening?
- Who is being affected by these actions? What Human Right(s) is being affected?
- What are the sequences of these violations?
- What do you think of this situation?
- What could be a possible solution to this situation?
